Our Track Record

- Kanava is managing a sub-award to VEGA/IESC on the USAID/Cambodia-funded Capacity Building of Cambodia's Local Organizations (CBCLO) program. We are piloting our ISD™ assessment tool, including mapping the NUPAS tool to it, and strengthening organizations to be able to be awarded direct funding from USAID.
- Kanava is implementing a subcontract with Abt Associates on the USAID/West Africa Trade and Investment Hub project where we manage the project's grants program, fielded a long-term local grants manager, and provide capacity building assistance. We recently assessed the capacity of five regional organizations for the project as part of a mid-term evaluation of these grantees. We used the ISD™ methodology and mapped the OCA tool to it.
- Kanava is also implementing a subcontract with DAI on the USAID/Afghanistan Regional Agricultural Development Program-North (RADP-N) program. Kanava assessed eight local organizations, both for- and non-profit, using the ISD™ assessment tool to determine their current management capacity. We will train these organizations in six areas to prepare them to pass the USAID Non-US Pre-award Survey (NUPAS), which is required for organizations to receive direct funding from USAID.

Ultimately, we want ISD™ to make a real difference in people's lives, which is why we're working toward a future in which the certification program becomes a franchisable, open system, available to all. That's why we've forged partnerships with institutions like the International Society for Performance Improvement (ISPI) to develop a certifying body, George Mason University School of Business, to help us test and refine the tool, and with GlobalWatch Technologies, to help us digitize ISD™ in a way that's easily accessible, especially in the developing world, and provide reporting functions.
